

Marine Limited Warranty (32 kW and Below)

Your Kohler product has been manufactured and inspected with care by experienced craftsmen. If you are the end user, Kohler Co. warrants, for the period indicated below, each product to be free from defects in materials and workmanship. Repair, replacement, or appropriate adjustment at Kohler Co.'s option will be furnished if the product, upon Kohler Co.'s inspection, is found to be properly installed, maintained, and operated in accordance with Kohler Co.'s instruction manuals. This warranty does not apply to malfunctions caused by damage, unreasonable use, misuse, repair or service by unauthorized persons, or normal wear and tear.

Kohler Product	Warranty Coverage
Marine Generator Sets and Accessories in Pleasure Craft	Generator sets and accessories are warranted for a period of five (5) years or two thousand (2000) hours, whichever occurs first, from the date of purchase by the original end user. For demonstration boats, coverage commences at fifty (50) hours or date of purchase by the first retail purchaser, whichever occurs first. Parts, labor, including diagnostic labor, limited travel, and removal and reinstallation are covered for the first and second years or two thousand (2000) hours, whichever occurs first, on warrantable repairs. Parts, labor, including diagnostic labor, limited travel, and removal and reinstallation are covered on selected components for the remaining years or two thousand (2000) hours, whichever occurs first, on warrantable repairs. Warranty is transferable to subsequent buyers of the vessel in which the generator set was originally installed. Selected components covered after the two (2) years and up to five (5) years or two thousand (2000) hours, whichever occurs first are: cylinder block, cylinder heads, crankshaft, camshaft, balance shafts, piston, rings, valves, valve lifters, manifolds, major castings, main stator, main rotor, excitation stator, and excitation rotor.
Marine Generator Sets and Accessories in Commercial/Rental or Leased Vessels	1 year from the date of purchase or 2000 hours (whichever occurs first) by the original end user.

The following will **not** be covered by the warranty:

1. Normal engine/generator wear.
2. Routine tuneups, tuneup ignition components, belts, hoses, clamps, filters, exhaust system components, gaskets, seawater impellers, and/or seals.
3. Damage caused by accidents, improper installation or handling, and/or improper storage.
4. Damage caused by water ingestion.
5. Damage caused by faulty repairs performed by a repair facility that is not an authorized Kohler service representative.
6. Damage caused by operation with improper fuel or at speeds, loads, conditions, modification, or installation contrary to published specifications or recommendations.
7. Original installation charges and startup costs.
8. Starting batteries and the following related expenses:
 - a. Labor charges related to battery service.
 - b. Travel expense related to battery service.
9. Rental of equipment during performance of warranty repairs.
10. Generator repairs made within the warranty period other than by an authorized Kohler service dealer without prior approval from the Kohler Co. Warranty Department.
11. Damage caused by negligent maintenance such as:
 - a. Failure to provide the specified type and sufficient quantity of lubricating oil, cooling air, and/or coolant.
 - b. Failure to provide adequate air intake and/or maintenance of the air intake system.
 - c. Failure to perform scheduled maintenance as prescribed in supplied manuals.
12. Engine fluids such as fuel, oil, or coolant/antifreeze.
13. Shop supplies such as adhesives, cleaning solvents, and rags.
14. Use of other-than-factory-supplied or -approved repair parts and/or procedures. Replacement of a failed Kohler part with a non-Kohler part voids Kohler warranty on this part or failures caused by this part.
15. Fuel injection pumps not repaired locally by an authorized servicing dealer.
16. Expenses incurred investigating performance complaints unless the problem is caused by defective Kohler materials or workmanship.
